

RESOLUTION NO. R-250259

WHEREAS, Los Angeles has been awarded the 1984 Summer Olympic Games; and

WHEREAS, a sufficient number of adequate venues and facilities may not be available in Los Angeles to accommodate all the various sports; and

WHEREAS, within the City of San Diego there exists one of the world's finest aquatic parks, a modern outdoor stadium seating in excess of 50,000 persons, a sports arena seating in excess of 14,000 persons, and a convention center; and

WHEREAS, The City of San Diego has in the past hosted national, international, and world championships in a variety of athletic events; and

WHEREAS, The City of San Diego has better facilities for hosting rowing, canoeing and yachting, and is particularly well suited to host preliminary and/or final competition in wrestling, soccer, basketball, and others; and

WHEREAS, the Greater San Diego Sports Association, a group of local sports enthusiasts, has requested that The City of San Diego invite the organizers of the 1984 Summer Olympic Games to consider San Diego as a satellite location for any events which cannot be held in Los Angeles; and

WHEREAS, the Greater San Diego Sports Association has offered to assist The City of San Diego and the Los Angeles Olympic Organizing Committee in the staging of events in San Diego; and

WHEREAS, sufficient dormitory housing exists to accommodate 3,000 athletes and team officials in the City of San Diego; and

WHEREAS, it is not intended that The City of San Diego will be required to expend any funds for capital improvements nor any funds beyond those routinely associated with similar activities; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Los Angeles Olympic Organizing Committee is hereby officially invited to stage appropriate Olympic sports in San Diego.

BE IT FURTHER RESOLVED, that the Greater San Diego Sports Association is designated the official San Diego Olympic Liaison Citizen Committee.

BE IT FURTHER RESOLVED, that it is not the intent of The City of San Diego to spend funds for the construction of capital facilities for the Olympic Games nor to make expenditures beyond those routinely associated with similar activities.
