WHEREAS, on October 17, 1978, the City Council adopted Resolution No. 222053 authorizing the Mayor and City Manager to execute an agreement with Penasquitos Properties conveying to the City 2,050 acres of land in the Penasquitos Canyon; and

WHEREAS, 1,800 acres of this land was to be conveyed immediately and 250 acres to be conveyed as subdivisions of the lands adjacent to said 250 acres are approved by the City; and

WHEREAS, Item 1, Paragraph 2, of the Agreement states, "Penasquitos shall place into escrow a Grant Deed transferring in fee simple to the City, a minimum of 1,800 acres as generally shown on Exhibit A, subject only to easements and rights-of-way of record and such reservations as are needed to obtain of City and other public agencies and utilities, easements necessary to support the development of the adjoining lands as shown on Exhibit A;" and

WHEREAS, the deed Penasquitos proposes to deposit in escrow does convey 1,800 acres or more as stipulated in the agreement; however, there have been some adjustments made in the boundary; and


WHEREAS, review of the various boundary adjustments and the comparison between the original property exhibit and the final property offered indicates that the necessary finding can be made and that the property now offered is in accordance with the intent of the original agreement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Council hereby finds and determines that all that property consisting of approximately 1,806 acres as described in the attachment hereto which is incorporated herein is hereby approved for conveyance by Penasquitos Properties to the City of San Diego to be utilized for open space park purposes.

BE IT FURTHER RESOLVED, that conveyance of said approximately 1,806 acres satisfies the obligation to convey 1,800 acres of property which obligation is set forth in that agreement between City and Penasquitos Properties dated January 17, 1979, which was approved by Council Resolution No. 222053 on October 17, 1978, a copy of which agreement is on file in the office of the City Clerk as Document No. 765539
