BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, a grant agreement, and any reasonable modifications thereof, with the Federal Aviation Administration for grading preparatory to the installing of an instrument landing system (ILS) and new aircraft parking areas at Montgomery Field, for a project total of \$397,961, of which \$77,244 is the City's approximate 20% share, under the terms and conditions set forth in the offer on file in the office of the City Clerk as Document

  No. \$250275; said grant offer is attached hereto and incorporated herein by reference.
  - 2. That the City Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$77,244 of funds generated by and from the City's airport operations from the General Fund (100/60531 Unallocated Reserve) to Airport Operations Division Montgomery Field (Fund 100/53621), and that expenditure of said funds is hereby authorized solely and exclusively for the purpose of providing funds for the above stated services.
  - 3. That the City Manager be, and he is hereby authorized and empowered to utilize City forces to perform work as part of

the City's required cash match in an amount not to exceed \$17,000, said amount to be reimbursed to the City's General Fund from funds allocated for this project.

4. That Resolution No. 223658 adopted by the City Council on June 4, 1979, be and it is hereby rescinded.
