BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. MCAHAN DESK OF SAN DIEGO, INC., 2. ARENSON OFFICE FURNITURE, 3. SAN DIEGO OFFICE SUPPLY, and 4. FISCHER OFFICE INTERIORS, are hereby accepted; and the City Manager is hereby authorized to execute contracts for furnishing OFFICE FURNITURE, except file cabinets, as may be required for a period of one (1) year beginning October 1, 1979 through September 30, 1980 per prices on file in the Purchasing Department as follows:
