

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the offer of CMC, A DIVISION OF PERTEC COMPUTER CORPORATION, is hereby accepted; and the City Manager is hereby authorized to execute a contract for LEASE OF DATA PROCESSING EQUIPMENT for a period of two (2) years beginning approximately September 1, 1979 through August 31, 1981 at a monthly lease cost of \$1,738.80; terms net 1 day plus sales tax, with an escalation of 2% after the first twelve (12) month period, plus estimated freight charges of \$175.00. Continuation of this lease into the second year is contingent upon Council appropriation of sufficient funds in the new fiscal year to cover the cost of the lease for the balance of the contract period.


