

RESOLUTION No. R-250297 (R-80-480)


Adopted on OCT 1 1979

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that Street Easement Deed of G.E.M. DEVELOPMENT CO., a General Partnership, executed in favor of The City of San Diego, conveying to said City a permanent easement and right-of-way for a public street and incidents thereto, over, under, along, and across a portion of Lots 28, 29 and 30 of Indiana Heights, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named 51ST STREET.

That the City Clerk is hereby authorized and directed to cause said deed, and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
