

RESOLUTION No. R-250299 (R-80-278)


Adopted on OCT 1 1979

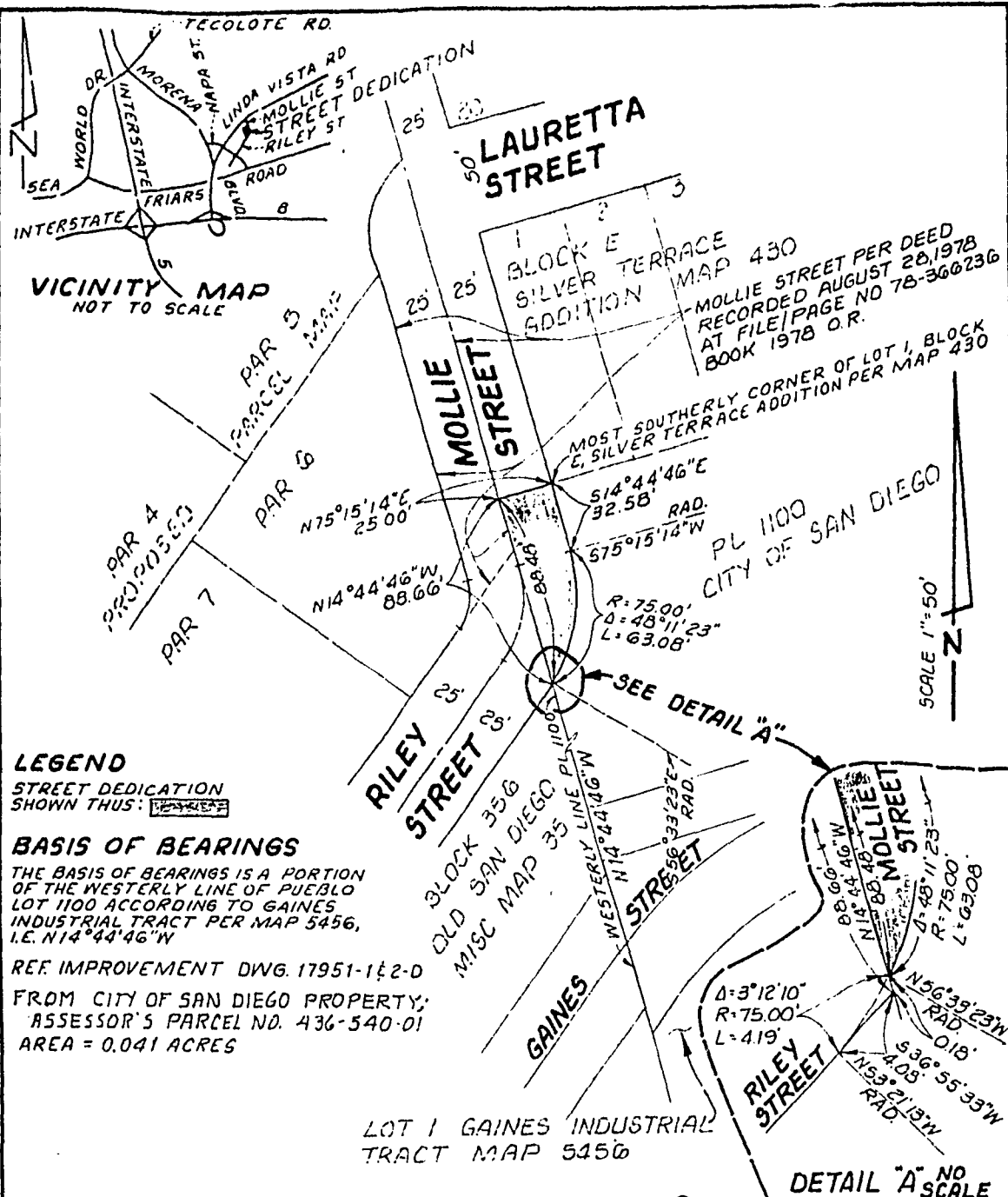
