BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That the City Manager and Planning Director are hereby directed to continue the City's Vernal Pool Resources Preservation Program as described in the draft report of July 15, 1979.
- 2. That the City Manager and the Planning Director are hereby directed to evaluate the potential elimination or degradation of vernal pools in land development permit applications and take appropriate action to protect and preserve the vernal pool resources until the Vernal Pool Resources Preservation Program is implemented.
- 3. That the City Manager is hereby directed to comply and fully cooperate with the United States Army Corps of Engineers' direction to suspend any currently existing land development permit until the implementation of the City's Vernal Pool Resources Preservation Program.
- 4. That the City Manager is authorized for and on behalf of said City to hire appropriate temporary staff and to retain appropriate expert and technical consultants as may be necessary to assist the City in the development and implementation of the Vernal Pool Resources Preservation Program.
- 5. That the expenditure of \$25,000 from the Vernal Pool Trust Fund (63021) of The City of San Diego is hereby authorized

solely and exclusively for the purpose of defraying the costs associated with the hiring of the consultants and temporary staff described in part 4 of this resolution.

- 6. That Resolution No. 222610, adopted January 16, 1979, authorizing an agreement with the California Department of Transportation (CALTRANS) which is on file in the office of the City Clerk as Document No. 765519, be and it is hereby rescinded.
- 7. That the City Council requests the cooperation and coordination of CALTRANS in the determination of mitigating measures for vernal pool losses associated with highway development.
- 8. That the City Council further states that it is the position of the City that these actions and the vernal pool preservation program do not create further commitments of City funds and in fact the City's actions are contingent upon the reciprocal commitments of state and federal finances wherein public participation is required.
