

RESOLUTION No. R-250321 (R-80-552)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. GENERAL ELECTRIC COMPANY, 2. MOTOROLA COMMUNICATIONS AND ELECTRONICS, INC., 3. SAN DIEGO FIRE EQUIPMENT CO., 4. SINCLAIR RADIO LABORATORIES, INC., 5. MICROWAVE ASSOCIATES, 6. RAYTRONICS, are hereby accepted; and the City Manager is hereby authorized to execute contracts for the purchase of COMMUNICATIONS EQUIPMENT per prices on file in the Purchasing Department as follows:

3. SAN DIEGO FIRE EQUIPMENT CO., for item 9, including all options as required for a period of one (1) year from the date of the original purchase order; terms net 30 days plus sales tax.
4. SINCLAIR RADIO LABORATORIES, INC., for item 16, as may be required for a period of one (1) year from the date of the original purchase order; terms net 30 days plus sales tax.
5. MICROWAVE ASSOCIATES, for item 17; terms net 30 days plus sales tax.
6. ROSS COMMUNICATIONS, for items 19, 23 & 25; terms 2% net 30 days plus sales tax.
7. RAYTRONICS, for item 24, including all options as may be required from the date of the original purchase order; terms net 30 days plus sales tax.
