Said Council hereby finds that that certain map surveyed by BYRL D. PHELPS, a Registered Civil Engineer, entitled "CABRILLO SQUARE Being a subdivision of Lots 1 through 4 inclusive and Lots 9 through 12 inclusive Block 20 Bayview Homestead, also known as Caruther's Addition, in the City of San Diego, County of San Diego, State of California, according to Map Nos. 150 and 254, filed in the office of the County Recorder of San Diego County January 29, 1873 and August 18, 1871, respectively, also Lots 'E' through 'H' inclusive, Block 187 of Horton's Addition, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by L. L. Lockling, in the office of County Recorder of San Diego County," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.
