

RESOLUTION No. R-350337 (R-80-611)

Adopted on OCT 2 1979

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby directed to:

(a) Expedite the design and processing of the San Diego River Pilot Channel Project;

(b) Execute the referenced Memorandum Agreement of Understanding with property owners and lessees; and

(c) Accept the cash contribution from property owners and lessees and deposit in Trust Fund Account No. 63021 for the sole purpose of constructing a pilot channel in this reach of the San Diego River.

BE IT FURTHER RESOLVED, that the addition of CIP 12-022, San Diego River Pilot Channel, to the FY 1980 Capital Improvement budget is hereby authorized.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$46,500 from the Flood Control and Drain Bond Fund Unallocated Reserve CIP 90727 to new CIP 12-022.

BE IT FURTHER RESOLVED, that the expenditure of \$46,500 is hereby authorized from CIP 12-022 solely and exclusively for the purpose of providing funds for design, construction and related costs of the above-mentioned project.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to advertise for bids on said project.
