

RESOLUTION No. R- 250347 (R- 80-637)



BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Auditor and Comptroller is hereby authorized to transfer the sum of \$6,500.00 from the Unallocated Reserve General Fund to the Allocated Reserve General Fund for the removal or demolition of the buildings located at 7596, 7612, 7630, 7636 Rowena Street, San Diego, California; said costs to be paid from the City Treasury and levied as a special assessment against the properties, pursuant to Municipal Code Section 91.02.0203.

BE IT FURTHER RESOLVED, that the expenditure of \$6,500.00 is hereby authorized from the Allocated Reserve General Fund for the sole and exclusive purpose of providing funds for said removal or demolition of the above-mentioned buildings.
