with the existing easement; and

WHEREAS, the aforementioned easement has never been used
for the purpose for which it was originally acquired; and

WHEREAS, the City has no present or prospective use for
the easement and the City Manager has recommended that the
City abandon its interest therein; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That the City of San Diego, by this resolution, does
hereby abandon whatever right, title or interest it may have
in the non-motor vehicular access easement, as more particularly
shown on Drawing No. 14624-B on file in the office of the City
Clerk as Document No. RR-250370 -1, which is by this
reference incorporated herein and made a part hereof.

That the City Clerk shall cause a certified copy of this
resolution attested by him under seal, to be recorded in the
office of the County Recorder.
