APPROVING MAP OF MEADOWVIEW SUBDIVISION

**OCT 15 1979**

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by LEO H. BARBOUR, a Registered Civil Engineer, entitled "MEADOWVIEW Being a subdivision of portions of Quarter Section Lots 28 and 51 of Rancho De La Nacion, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 166, made by George S. Morrill, filed in the office of the County Recorder of said San Diego County, May 11, 1869.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following: Glencrest Drive, Parkwood Drive and Timberwood Place for public purposes, and said streets are hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.



BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider, DEGEN DEVELOPMENT COMPANY, a California corporation, that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 757438, on file in the office of the City Clerk, and in reliance on said assurance does hereby accept the final map of MEADOWVIEW.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
