Said Council hereby finds that that certain map surveyed by LEO H. BARBOUR, a Registered Civil Engineer, entitled "MEADOWVIEW Being a subdivision of portions of Quarter Section Lots 28 and 51 of Rancho De La Nacion, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 166, made by George S. The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and that those easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider, DEGEN DEVELOPMENT COMPANY, a California corporation, that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 757438, on file in the office of the City Clerk, and in reliance on said assurance does hereby accept the final map of MEADOWVIEW.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
