

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR-250406, quitclaiming to AE REALTY PARTNERS, a partnership, all the City's right, title and interest in the drainage and sewer easements, as more particularly described in said quitclaim deed.
