

RESOLUTION No. R- 250430 (R-80-430)

Adopted on OCT 15 1979 (REV.)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Auditor and Comptroller is hereby authorized and directed to transfer funds presently deposited in the Low-Income Housing Capital Outlay Fund No. 30249, and to transfer any revenues deposited in said fund in the future, to the Housing Authority of The City of San Diego, to be used by said Authority and the San Diego Housing Commission solely and exclusively for the acquisition, construction and completion of permanent public improvements and for the acquisition, construction and completion of real property and other improvements of a permanent character in connection with the acquisition and development of low-income housing.


BE IT FURTHER RESOLVED, that all property and improvements acquired with such funds shall be and remain the property of The City of San Diego.

BE IT FURTHER RESOLVED, that the San Diego Housing Commission is hereby authorized to approve expenditures of said funds subject to the following conditions: (1) Expenditures shall be subject to prior review and approval by the City Auditor and Comptroller and the City Attorney, (2) Action by the Housing Commission authorizing expenditure of such funds shall be subject to review by the Housing Authority at the request of any member of the City Council or the City

Manager, which request shall be expressed within seven days after Housing Commission action pursuant to the review provisions of Ordinance No. 12515 (New Series) which ordinance established the San Diego Housing Commission.


