BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the City Auditor and Comptroller is hereby authorized to add CIP 52-262 (COLLEGE AVE. - STORM DAMAGE REPAIR) to the FY 1980 Capital Improvements Program.
2. That the bid of \$103,315.00 by METRO-YOUNG CONSTRUCTION COMPANY, a division of OLSON CONSTRUCTION COMPANY, a corporation, FOR STORM DAMAGE REPAIRS ON COLLEGE AVENUE NORTH OF EL CAJON BOULEVARD in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 767219.
3. That the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$146,400.00 from CIP 90-220, Fund #3219 (Gasoline Tax Fund Unallocated Reserve) and \$8,515.00 from CIP 58-004, Fund #3245 (Miscellaneous Improvements on City Streets to CIP 52-262).
4. That the expenditure, not to exceed \$146,400.00 from Fund #3219 and \$8,515.00 from Fund #3245, of the City of San Diego are hereby authorized solely and exclusively for providing funds for said project and related costs.
