APPROVING MAP OF AVOCADO VISTA UNIT NO. 4, AND
ACKNOWLEDGING RECEIPT OF SUBDIVIDER'S ASSURANCE
OF COMPLIANCE WITH THE AFFIRMATIVE MARKETING PROGRAM.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by GERRY SIMON, a Registered Civil Engineer, entitled "AVOCADO VISTA UNIT NO. 4 Being a subdivision of a portion of Lots "M" and "N" of Encanto according to Map thereof No. 749 filed in the office of the County Recorder of San Diego County on May 6, 1893, together with portions of Benson Avenue (formerly Boston Avenue) and 65th Street (formerly Klauber Avenue) as dedicated to public use, and a portion of Benson Avenue as closed and vacated to public use, all in the City of San Diego, County of San Diego, State of California.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Jojo Court, Terol Court, a portion of 65th Street and a portion of Sullivan Avenue for public purposes; and said streets are hereby declared to be public streets and portions of public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Sullivan Avenue, adjacent and contiguous to Lots 161 through 165, all as shown on this map within this subdivision.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.

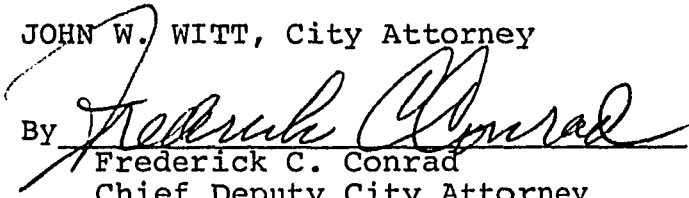
The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portions of public streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider, the DE FREITAS COMPANY, a California corporation, that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 757438, on file in the office of the City Clerk, and in reliance on said assurance does hereby accept the final map of AVOCADO VISTA UNIT NO. 4.

BE IT FURTHER RESOLVED, that pursuant to the representation and request of the subdivider, said Council hereby determines and declares that construction on Lot Nos. 182 and 183 of Avocado Vista Unit No. 4 shall be limited to dwelling units of one story in height.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
