

RESOLUTION NO. R-250456 (R.80-344)

VACATION OF A PORTION OF MARILOU ROAD IN LOT 4 OF DELTA NO. 1, MAP 5007 OCT 22 1979

WHEREAS, it is proposed that a portion of MARILOU ROAD IN LOT 4 OF DELTA NO. 1, MAP 5007 be vacated; and

WHEREAS, there is no present or prospective use for the street either for the public street system for which the right-of-way was originally acquired or for any other public use of a like nature that can be anticipated; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent with the General Plan or an approved Community Plan; and


WHEREAS, the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, California, that a portion of MARILOU ROAD IN LOT 4 OF DELTA NO. 1, MAP 5007 as more particularly referred to in Resolution of Intention No. R-250219 is unnecessary for present or prospective public street purposes.

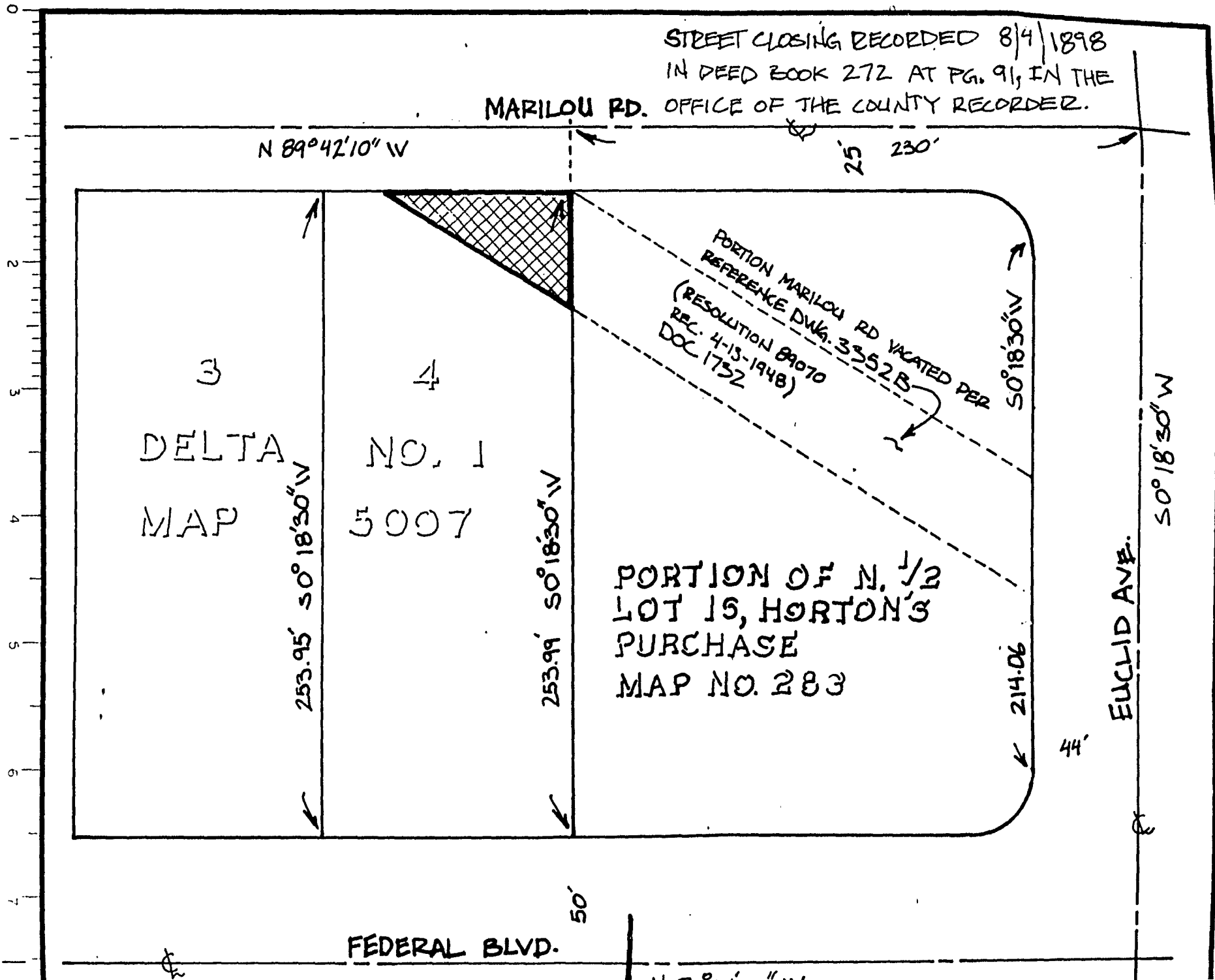

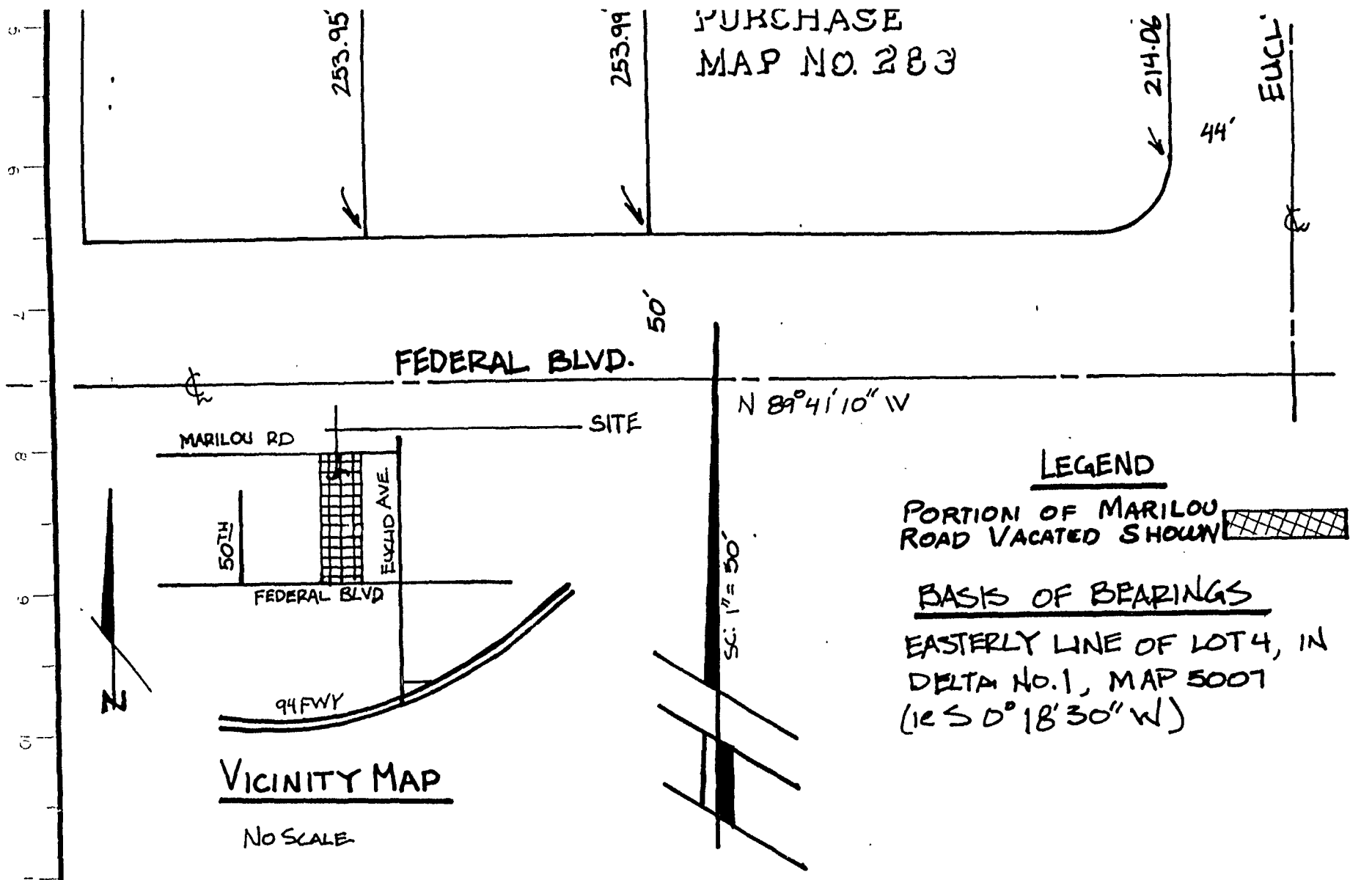
