

RESOLUTION NO. R-250459 (R.80-672)

WHEREAS, SAN DIEGO GAS & ELECTRIC COMPANY, has requested an exchange of easements for underground and aboveground electrical facilities affecting a portion of Rancho Penasquitos; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are approximately equal; and

WHEREAS, the easements to be acquired will serve the same use and purpose as the easements to be quitclaimed by the City; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the acceptance by the City Manager of that deed of SAN DIEGO GAS & ELECTRIC COMPANY, a corporation, executed in favor of The City of San Diego, conveying to said City certain underground and aboveground easement rights in a portion of Rancho Penasquitos, as more particularly described in said deed, is hereby approved.

2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a deed conveying to SAN DIEGO GAS & ELECTRIC COMPANY, a corporation, an easement for underground and aboveground electrical facilities affecting a portion of Rancho Penasquitos, as more particularly described in said deed on file in the office of the City Clerk as Document No. RR-250459.

3. That the City Clerk of said City is hereby authorized and directed to deliver said deeds, and a certified copy of this resolution to the Property Director for further handling.
