WHEREAS, on May 3, 1978, Lot 6 of Torrey Pines Science OCT 231979

Park Unit No. 2 was conveyed to Ramco Center, Ltd, by the

Economic Development Corporation, acting for the City of

San Diego,; and

WHEREAS, an agreement entered into by Ramco in consideration of the conveyance contained a provision requiring Ramco to apply within 120 days for all permits necessary to construct a 35,000 square-foot building, and the agreement further required the commencement of construction and the diligent completion of construction of said building; and

WHEREAS, the applications for permits were made but Ramco has not pursued the actual issuance of said permits and pursuant to the application provisions, the applications expired 180 days after they were submitted and, therefore, applications for permits are no longer pending; and

WHEREAS, as a result of Ramco's failure to pursue the issuance of such permits, Ramco is in default of its agreement; and

WHEREAS, said agreement grants to City an option to repurchase Lot 6 in the event of a default of the agreement and City desires to exercise its option to repurchase; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That Ramco Center, Ltd., is hereby declared to be in default of its obligation to apply for, acquire and utilize

permits for the construction of a 35,000 square-foot building as required in that reversionary clause agreement, a copy of which is on file in the office of the City Clerk as Document No. Response

BE IT FURTHER RESOLVED, that the City hereby exercises its option to repurchase Lot 6 of Torrey Pines Science Park Unit No. 2 for the original purchase price.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to accept a grant deed from Ramco Center, Ltd., or its assigns, for said Lot 6.

BE IT FURTHER RESOLVED, that the addition of CIP 39-016.3 (Torrey Pines Science Park Unit No. 2, Lot 6 - Repurchase) be made to the FY 1980 Capital Improvements Program.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to transfer \$356,500 from Industrial Development Funds from CIP 39-029 (Dells Area - Redevelopment) to CIP 39-016.3.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$356,500 from Industrial Development Fund 30248 for said repurchase cost and related expenses is hereby authorized and approved.
