BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$91,223.00 by METRO YOUNG CONSTRUCTION CO. A DIVISION OF OLSON CONSTRUCTION CO., a corporation, and authorizing a contract FOR STORM DAMAGE REPAIRS ON NORTH TORREY PINES ROAD ONE HALF (½) MILE NORTH OF RESERVOIR, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 767317.
2. That the City Auditor and Comptroller is hereby authorized to add CIP 52-267 to the FY 1980 Capital Improvements Program.
3. That the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$18,100 from CIP 90-220, Gas Tax Reserve and \$110,300 from Disaster Assistance Fund to CIP 52-267.
4. That the expenditure of \$128,400 from CIP 52-267, of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs.
