

RESOLUTION No. R- 250498 (R- 80-726)


Adopted on OCT 29 1979

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that Street, Water and Drainage Easement Deed of GENSTAR DEVELOPMENT, INC., a New York Corporation, executed in favor of The City of San Diego, bearing date of September 10, 1979, conveying to said City the permanent easement and right of way to construct, reconstruct, maintain, operate and repair a street or streets, drain or drains, and water main or mains including any or all appurtenances thereto, together with the right of ingress and egress, over, under, along and across that portion of the West Half of Pueblo Lot 1301 of the Pueblo Lands of San Diego, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed as Parcel 2 is hereby dedicated as and for a public street and the same is hereby named MC KELLAR DRIVE; and the land therein conveyed as Parcel 3 is hereby dedicated as and for a public street and the same is named NOBEL DRIVE.

That the City Clerk is hereby authorized and directed to cause said deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
