

RESOLUTION NO. R-250501 (R.80-586)

WHEREAS, it is proposed that ROAD SURVEY 466 IN THE **OCT 29 1979**
SOUTHEAST QUARTER OF THE NORTHEAST QUARTER AND THE NORTHEAST
QUARTER OF THE SOUTHEAST QUARTER OF SECTION 10, TOWNSHIP 15
SOUTH, RANGE 3 WEST, S.B.M., be vacated; and

WHEREAS, there is no present or prospective use for the
street either for the public street system for which the
right-of-way was originally acquired or for any other public
use of a like nature that can be anticipated; and

WHEREAS, the public will benefit from the vacation through
improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent with
the General Plan or an approved Community Plan; and

WHEREAS, the public street system for which the right-of-
way was originally acquired will not be detrimentally affected
by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
California, that ROAD SURVEY 466 IN THE SOUTHEAST QUARTER OF THE
NORTHEAST QUARTER AND THE NORTHEAST QUARTER OF THE SOUTHEAST
QUARTER OF SECTION 10, TOWNSHIP 15 SOUTH, RANGE 3 WEST, S.B.M.,
as more particularly referred to in Resolution of Intention
No. R-250374, is unnecessary for present or
prospective public street purposes.

BE IT FURTHER RESOLVED, that ROAD SURVEY 466 IN THE SOUTHEAST
QUARTER OF THE NORTHEAST QUARTER AND THE NORTHEAST QUARTER OF
THE SOUTHEAST QUARTER OF SECTION 10, TOWNSHIP 15 SOUTH, RANGE 3
WEST, S.B.M., as more particularly shown on Drawing No. 14577-B
on file in the office of the City Clerk as Document No. R-250374

which said Drawing is attached hereto and made a part hereof, be, and the same is hereby ordered vacated.

BE IT FURTHER RESOLVED, that the requirement contained in Council Policy 600-15 for Planning Commission review of the proposed vacation of a full width section of any street or alley is hereby waived.

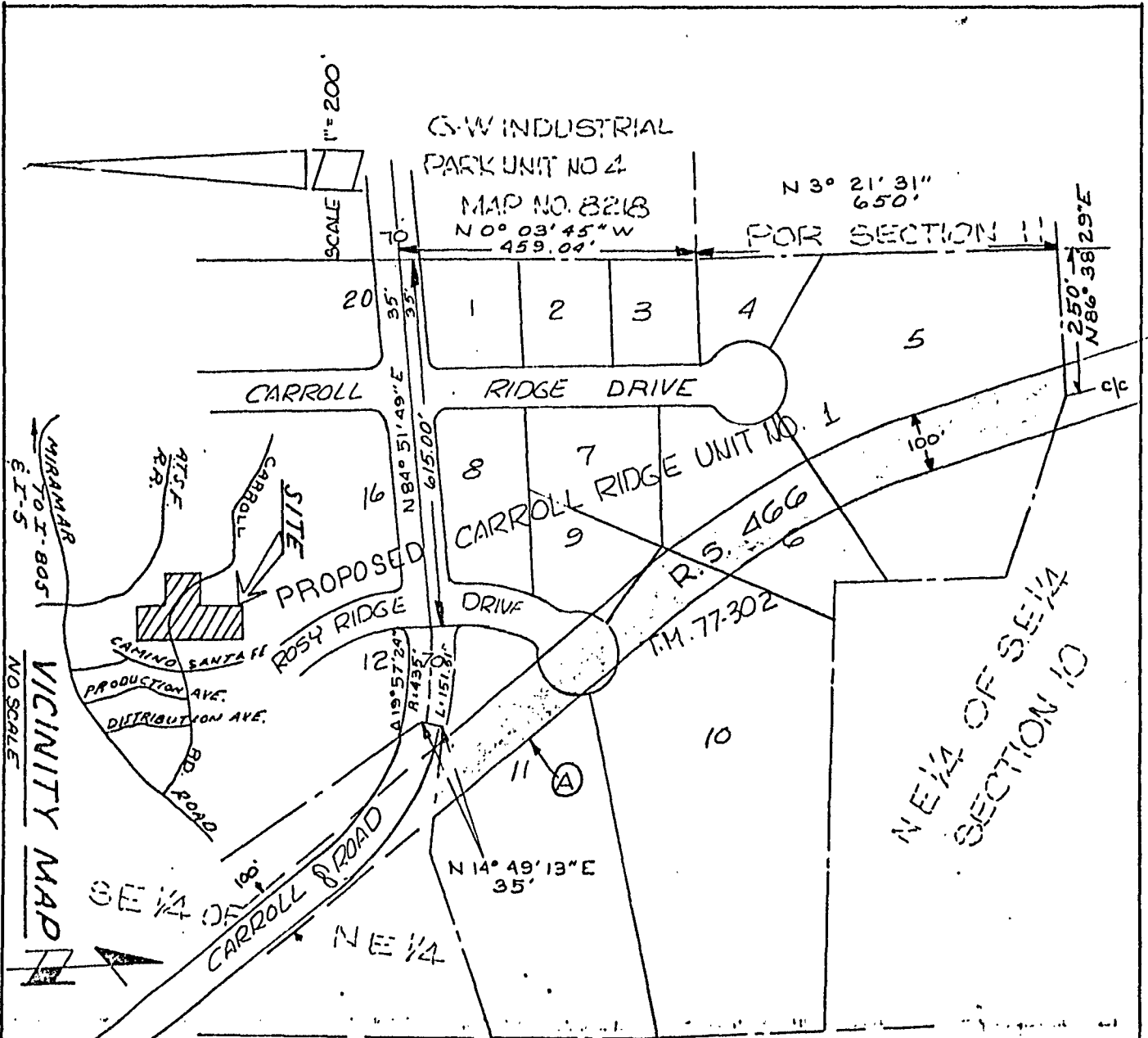
