BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to do by City forces the above referenced miscellaneous work at Highland-Landis Park and Recreation Center in the City of San Diego, California, pursuant to recommendation of the City Manager and submission of estimates by him indicating that such work can be accomplished more quickly and at less cost than by contract.
