BE IT RESOLVED, by the Council of The City of San Diego as follows:


That the City Manager be and he is hereby authorized to implement a 12-month project called Victim/Witness Assistance Program for the Elderly.

RR- 250516-1, and RR- 250516-2, respectively.

BE IT FURTHER RESOLVED, that the Project Director is hereby authorized to engage in fund-raising for the project on behalf of the City.




