WHEREAS, The City of San Diego has had to deploy law enforcement personnel on a stepped-up level to respond to the aftereffects of a midair collision between two aircraft on September 25, 1978; and

WHEREAS, The City of San Diego responded to this disaster on that date and subsequent days by incurring extraordinary costs in the amount of \$221,994; and

WHEREAS, Chapter Law 1204 (SB 583) provides that, upon application being made by the governing body of the local agency, eighty percent (80%) reimbursement is available to local agencies to meet the added burden of providing law enforcement protection under extraordinary circumstances; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to apply to the Controller of the State of California for reimbursement to The City of San Diego for extraordinary costs incurred while providing law enforcement services as a result of the midair collision on September 25, 1978.

BE IT FURTHER RESOLVED AND CERTIFIED, that The City of San Diego was required to deploy on a stepped-up basis law enforcement personnel to respond to extraordinary circumstances within its jurisdiction as a result of the disaster.

BE IT FURTHER RESOLVED AND CERTIFIED, that The City of San Diego has incurred extraordinary costs as set forth in Senate Bill 583 to provide the stepped-up level of law enforcement service due to extraordinary circumstances in order to protect the peace, health, safety and welfare of the citizens of the City of San Diego due to the midair disaster.

BE IT FURTHER RESOLVED AND CERTIFIED, that the law enforcement functions of the San Diego Police Department for which this claim of reimbursement is filed were performed with impartiality and fairness.
