WHEREAS, the San Diego Police Department was requested by the Imperial Valley Sheriff's office, pursuant to mutual aid agreements, to provide personnel and equipment to assist in policing of an agricultural labor dispute in February 1979; and

WHEREAS, the San Diego Police Department responded to the mutual aid request by providing a total of 63 persons and 25 vehicles during a four (4) day period resulting in an expenditure of \$52,842.00 in local taxpayers' funds; and

WHEREAS, Chapter Law 1204 (SB 583) provides that upon application being made by the governing body of the local agency, eighty percent (80%) reimbursement is available to local agencies for extraordinary costs incurred in fiscal year 1978-79 to meet the added burden of providing law enforcement protection under extraordinary circumstances; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to apply to the Controller of the State of California for reimbursement to The City of San Diego for extraordinary costs incurred while providing law enforcement mutual aid to Imperial County during said agricultural labor dispute as set forth on the claim for reimbursement of Extraordinary Cost for Mutual Aid to Imperial County on file in the office of the City Clerk as Document No. RR-250521 .

BE IT FURTHER RESOLVED AND CERTIFIED, that the San Diego Police Department was required to deploy its own law enforcement personnel on a stepped-up level to respond to extraordinary circumstances at the request of the Imperial Valley Sheriff in order to honor mutual aid agreements with that agency.

BE IT FURTHER RESOLVED AND CERTIFIED, that the San Diego Police Department has incurred extraordinary costs as set forth in Senate Bill 583 and as set forth in the above referenced claim for reimbursement to provide the stepped-up level of law enforcement service due to extraordinary circumstances in order to protect the peace, health, safety and welfare of the citizens of the Imperial Valley due to the agricultural labor dispute.

BE IT FURTHER RESOLVED AND CERTIFIED, that the law enforcement functions of the San Diego Police Department for which this claim for reimbursement is filed were performed with impartiality and fairness and there were no citizens' complaints against the personnel of the Police Department as a result of their actions in this incident.
