That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Mary M. Kaerth	Personnel	\$20	Ms. Kaerth is an Associate Personnel Analyst. She suggested that a standard response card be modified for use as a postcard. This is expected to save a significant amount in postage annually.
Conrad S. Grocholski	Park and Recreation	\$20	Mr. Grocholski is a Groundskeeper in the Park Division. He suggested that hose bibs be removed from certain beach facility locations. This is expected to produce significant water consumption savings.
Edna Gonzales	Police	\$20	Ms. Gonzales is an Intermediate Typist in the Support Services Bureau. She suggested that Field Interrogation Logs be eliminated. This is expected to save a significant amount of clerical time annually.
Kitty S. Norman	City Clerk	\$20	Ms. Norman is an Intermediate Typist in the Docket Preparation Section. She suggested that shorter tapes be used to copy Council Docket items. This is expected to save \$206 a year.
Robert N. Edgett	Police	\$20	Mr. Edgett is a Police Officer in the Traffic Bureau. He suggested that a vehicle hazard be corrected. Although the design hazard could not be corrected, Officers were notified that the hazard existed and to exercise caution. This was considered to be a significant safety suggestion.
