Michael D. Shea	Fire	\$20	Mr. Shea is a Firefighter. He suggested that a teleprinter be purchased to decrease radio time. Although it is currently impossible to purchase a teleprinter, procedures are being changed to reduce radio air time. This was considered to be a significant operational improvement.
James L. Strawn	Fire	\$20	Mr. Strawn is a Firefighter. He suggested that a program be developed for the cleaning and maintenance of Nomex Brush Coats. This was considered to be a significant operational improvement.
Vincent DeLeva	General Services	\$20	Mr. DeLeva is an Electrician in the Communications and Electrical Division. He suggested that a street light in a certain location be protected from constant damage from vehicles. The street light in question is being relocated. This was considered to be a significant operational improvement.
