

RESOLUTION NUMBER R-250532

Adopted on OCT 30 1979

WHEREAS, EDWARD L. GALE, hereafter referred to as "Owner/Permittee," filed an application to construct 14 dwelling units with parking and landscaping in the R-1-5 and R-1-40 Zones, on property located north of Madison Avenue, between Maryland and North Avenues, more particularly described as Lot 35, Mission Cliff Gardens, Map No. 2268 and a portion of Pueblo Lot 1111 of the Pueblo Lands of San Diego, Miscellaneous Map No. 36; and

WHEREAS, on August 30, 1979, The Planning Commission of The City of San Diego made its findings of facts, denied Planned Residential Permit No. 149, and filed said decision in the office of the City Clerk on September 18, 1979; and

WHEREAS, on September 14, 1979, pursuant to the provisions of Section 101.0900 of the Municipal Code, EDWARD L. GALE appealed the decision of the Planning Commission; and

WHEREAS, said appeal was set for public hearing on October 30, 1979; and

WHEREAS, the Council of The City of San Diego received for its consideration documentary, written and oral testimony and heard from all interested parties present at the public hearing;


NOW, THEREFORE,
