LICENSE RULING NO. 5

The purpose of this ruling is to publish a complete list of businesses granted exemption from the Business License Statute.

The following businesses are specifically granted exemption under Chapter 31 of the Municipal Code:

1. Charitable institutions
2. Charity - promotions for 50% or more of gross receipts are solely for charitable purposes
3. Charity - door to door sales
4. Convention event
5. Credit Unions
6. Blind persons - sole owner of business

Businesses granted exempt status due to control by other State and Federal statutes which preempt the field are as follows:

1. Alcoholic Beverages
2. Bail Bond
3. Banks
4. Insurance
5. Interstate Commerce
6. Newspaper Publications (except for advertising)
7. Newsboys
8. Radio Stations
9. Public Utilities Commission Licensees
