APPROVING MAP OF SANTA FE VISTAS UNIT NO. 1

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by BYRL D. PHELPS, a Registered Civil Engineer, entitled "SANTA FE VISTAS UNIT NO. 1 Being a subdivision of a portion of Lot 12 in Block 10; Lots 4, 5, 6 and 9 in Block 6; Lots 7, 8 and 9 and portions of Lots 4 and 5 in Block 7 of Bay View Addition, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 271, filed in the office of the County Recorder of San Diego County, July 23, 1887, together with that portion of Yuma Street adjoining Lot 6 in Block 6 on the south as vacated and closed to public use by the Council of The City of San Diego, Resolution No. 214723, a copy of which recorded December 3, 1975 as File No. 75-340854.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public EUREKA STREET for public purposes, and said street is hereby declared to be a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.


