WHEREAS, The City of San Diego is the owner of a portion of the Oaks Tract of Rancho San Bernardo, Map No. 1415; and

WHEREAS, said land has been determined to be surplus to all City needs; and

WHEREAS, the City desires to negotiate the sale of said land to TED J. BUSCH and ESTHER D. BUSCH, the adjacent property owners, under the provisions of Section 22.0902 of the San Diego Municipal Code; and

WHEREAS, the value of the property to be conveyed by the City, as established by an Independent Fee Appraisal, is the sum of Nineteen Thousand Seven Hundred Fifty Dollars (\$19,750); and

WHEREAS, no real estate broker's commission shall be paid; and

WHEREAS, the sale of the aforementioned property is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That that certain real property right described in that grant deed on file in the office of the City Clerk as Document No. RC-250572, be, and the same is hereby determined to be surplus and is hereby authorized to be sold by negotiation for the sum of Nineteen Thousand Seven Hundred Fifty Dollars (\$19,750) to TED J. BUSCH and ESTHER D. BUSCH, the adjacent property owners.



That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a grant deed, which is on file in the office of the City Clerk as Document No. RC-250572, granting to TED J. BUSCH and ESTHER D. BUSCH, the adjacent property owners, a portion of the Oaks Tract of Rancho San Bernardo, Map No. 1415, as more particularly described in said grant deed.

3. That no broker's commission shall be paid by City on the herein-described negotiated sale.

4. That the above-described property is hereby removed from the San Pasqual Agricultural Preserve, which Preserve was established by Council Resolution No. 200244.

5. That the City Clerk of said City is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Department for further handling.
