- 3. That no broker's commission shall be paid by City on the herein-described negotiated sale.
- 4. That the above-described property is hereby removed from the San Pasqual Agricultural Preserve, which Preserve was established by Council Resolution No. 200244.
- 5. That the City Clerk of said City is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Department for further handling.
