

RESOLUTION NO. RR-250580 (R. 80-721)

WHEREAS, on December 5, 1978, the Council of The City of **NOV 5 1979**
San Diego adopted Ordinance No. 12515 (New Series) creating
the San Diego Housing Commission to advise and assist the
Housing Authority in the operation of housing programs pur-
suant to the Housing Authorities Law of the State of California;
and

WHEREAS, the City has entered into a grant agreement with
the U. S. Department of Housing and Urban Development (HUD) to
carry out the Community Development Block Grant Program within
the City of San Diego; and

WHEREAS, the City desires to contract with the San Diego
Housing Commission to provide certain services in connection
therewith, and more particularly to administer a program for
the acquisition of sites for low and moderate income housing
within the City of San Diego; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That the City Manager is hereby authorized and empowered
to execute, for and on behalf of The City of San Diego, an
agreement with the San Diego Housing Commission, for the purpose
of administering a program for the acquisition of sites for low
and moderate income housing within the City of San Diego, under
the terms and conditions set forth in that agreement on file in
the office of the City Clerk as Document No. RR-250580.

BE IT FURTHER RESOLVED, that the City Council hereby specifically retains the right to review proposed sites prior to actual acquisition by the Housing Commission.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$850,024 for said acquisition and related costs of administering such program is hereby authorized and approved.




CERTIFICATION OF UNALLOTTED BALANCE
