

RESOLUTION NO. R-250588

A RESOLUTION DETERMINING AND DECLARING THAT THE PUBLIC INTEREST, CONVENIENCE AND NECESSITY OF THE CITY OF SAN DIEGO REQUIRE THE DEVELOPMENT OF THE RADIO CANYON - CHOLLAS OPEN SPACE PROGRAM IN PORTIONS OF LOT 18 OF THE RANCHO MISSION OF SAN DIEGO, PORTIONS OF LOTS 1 TO 7, INCLUSIVE, OF BLOCK 9 AND PORTIONS OF LOTS 1 TO 12, INCLUSIVE, OF BLOCK 10 OF LARCHMONT, IN THE CITY OF SAN DIEGO, COUNTY OF SAN DIEGO, STATE OF CALIFORNIA; AND THAT THE PUBLIC INTEREST, CONVENIENCE AND NECESSITY DEMAND THE ACQUISITION OF FEE TITLE TO SAID PROPERTY FOR SAID RADIO CANYON - CHOLLAS OPEN SPACE PROGRAM; AND DECLARING THE INTENTION OF THE CITY OF SAN DIEGO TO ACQUIRE SAID PROPERTY UNDER EMINENT DOMAIN PROCEEDINGS; AND DIRECTING THE CITY ATTORNEY OF THE CITY OF SAN DIEGO TO COMMENCE AN ACTION IN THE SUPERIOR COURT OF THE STATE OF CALIFORNIA, IN AND FOR THE COUNTY OF SAN DIEGO, FOR THE PURPOSE OF CONDEMNING AND ACQUIRING SAID PROPERTY.

WHEREAS, the Council of The City of San Diego has provided notice to those persons designated in Section 1245.235, Code of Civil Procedure and also has provided all persons a reasonable opportunity to appear and be heard on the matters referred to in Section 1240.030, Code of Civil Procedure; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

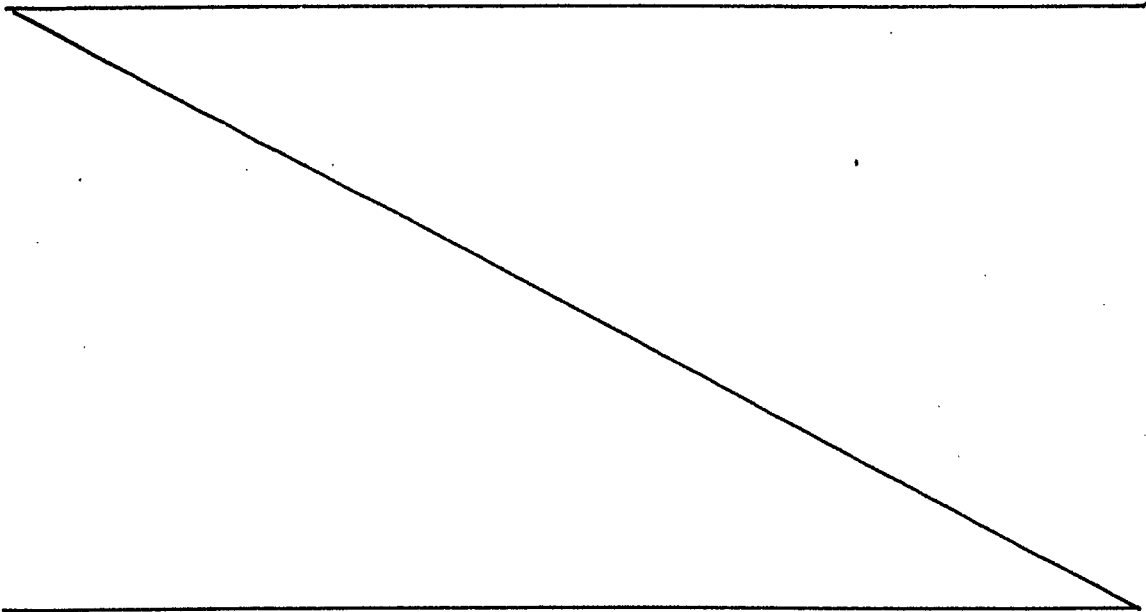
Section 1. That the public interest, convenience and necessity of The City of San Diego, and the inhabitants thereof, require the development of the Radio Canyon - Chollas Open Space Program in portions of Lot 18 of Rancho Mission, portions of Lots 1 to 7, inclusive, of Block 9 and portions of Lots 1 to 12, inclusive, of Block 10 of Larchmont,

as more particularly described hereinafter.

Section 2. That the public interest, convenience and necessity of said City, and the inhabitants thereof, demand the acquisition and taking of fee title to said property for the development of the Radio Canyon - Chollas Open Space Program, said real property lying within the City of San Diego, County of San Diego, State of California.

Section 3. That Section 220, the Charter of The City of San Diego; Sections 1240.010, 1240.110 and 1240.120, Code of Civil Procedure; Parks and Playgrounds Act of 1909; Sections 6950-6954, 37350.5 and 51063, Government Code; and Section 61.0603 et seq., San Diego Municipal Code permit the acquisitions referenced herein.

Section 4. That the parcels of real property sought to be condemned are described as follows:



THE LAND REFERRED TO HEREIN IS SITUATED IN THE STATE OF CALIFORNIA, COUNTY OF SAN DIEGO, AND IS DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT OF INTERSECTION OF THE EAST LINE OF SAID LOT 18 WITH THE WESTERLY PROLONGATION OF THE CENTER LINE OF FULMAR STREET (FORMERLY SIXTH AVENUE) AS SHOWN ON EMPIRE ADDITION TO ENCANTO HEIGHTS, ACCORDING TO MAP THEREOF NO. 1254, FILED IN THE OFFICE OF COUNTY RECORDER OF SAN DIEGO COUNTY, THE NORTHEAST CORNER OF SAID LOT 18 BEARS NORTH $0^{\circ}36'59''$ WEST FROM SAID POINT; THENCE SOUTH $56^{\circ}00'19''$ WEST 1550.30 FEET; THENCE SOUTH $69^{\circ}50'53''$ WEST 313.16 FEET; THENCE SOUTH $2^{\circ}54'25''$ WEST 586.64 FEET; THENCE SOUTH $58^{\circ}45'10''$ WEST 799.74 FEET TO AN ANGLE POINT IN THE BOUNDARY LINE OF THE LAND DESCRIBED IN DEED TO LOGAN HEIGHTS CONGREGATIONAL CHURCH, RECORDED JANUARY 24, 1963 AS DOCUMENT NO. 15111 OF OFFICIAL RECORDS; THENCE ALONG THE BOUNDARY LINE OF SAID LAND NORTH $89^{\circ}55'22''$ EAST 13.17 FEET TO A TANGENT 230 FOOT RADIUS CURVE, CONCAVE NORTHWESTERLY; THENCE EASTERLY ALONG SAID CURVE 125.09 FEET THROUGH AN ANGLE OF $31^{\circ}09'40''$; THENCE TANGENT TO SAID CURVE NORTH $58^{\circ}48'42''$ EAST 102.96 FEET; THENCE SOUTH $36^{\circ}27'24''$ EAST 216.62 FEET; THENCE SOUTH $19^{\circ}11'50''$ WEST 140.10 FEET TO A POINT IN THE NORTHERLY LINE OF THE LAND DESCRIBED IN DEED TO THE SAN DIEGO UNIFIED SCHOOL DISTRICT RECORDED OCTOBER 22, 1962 AS DOCUMENT NO. 180908 OF OFFICIAL RECORDS; THENCE ALONG THE BOUNDARY LINE OF SAID LAND, SOUTH $89^{\circ}48'10''$ EAST TO AN ANGLE POINT THEREIN AND SOUTH $0^{\circ}36'39''$ EAST 120.01 FEET TO THE SOUTHEASTERLY CORNER THEREOF BEING THE NORTHEAST CORNER OF THE LAND DESCRIBED IN DEED TO THE SAN DIEGO UNIFIED SCHOOL DISTRICT, RECORDED IN BOOK 6611, PAGE 508 OF OFFICIAL RECORDS, BEING ALSO A POINT IN THE ARC OF A 700 FOOT RADIUS CURVE, CONCAVE NORTHEASTERLY, A RADIAL LINE OF SAID CURVE BEARS SOUTH $82^{\circ}24'07''$ WEST (RECORD SOUTH $82^{\circ}24'50''$ WEST) TO SAID POINT; THENCE SOUTHEASTERLY ALONG SAID CURVE 443.66 FEET; THENCE TANGENT TO SAID CURVE SOUTH $43^{\circ}54'43''$ EAST 269.61 FEET (RECORD SOUTH $43^{\circ}54'$ EAST 269.46 FEET) TO AN INTERSECTION WITH THE NORTHEASTERLY PROLONGATION OF THE CENTER LINE OF LUBER STREET, AS SHOWN ON EMERALD HILLS ESTATES, ACCORDING TO MAP THEREOF NO. 3597, FILED IN THE OFFICE OF COUNTY RECORDER OF SAN DIEGO COUNTY; THENCE SOUTH $46^{\circ}44'50''$ WEST 14.21 FEET (RECORD SOUTH $46^{\circ}06'$ WEST 14.37 FEET) TO THE NORTHEASTERLY EXTREMITY OF SAID CENTER LINE, BEING ALSO A POINT IN THE NORTHERLY BOUNDARY LINE OF THE CITY OF SAN DIEGO, AS PER RESOLUTION NO. 21291; THENCE SOUTH $89^{\circ}48'40''$ EAST ALONG SAID NORTHERLY LINE 1413.89 FEET TO THE EASTERLY LINE OF SAID LOT 18; THENCE NORTH $0^{\circ}36'59''$ WEST ALONG SAID EASTERLY LINE 2923.79 FEET TO THE POINT OF BEGINNING, AND LYING NORTHEASTERLY OF LOT 94, SOUTHEASTERLY OF LOTS 95 TO 104 INCLUSIVE, SOUTHERLY OF LOTS 106, 107 AND 109 AND OF GRAVITY WAY AND 60TH STREET, ALL AS SHOWN ON MAP NO. 7629 OF EMERALD HILLS ANNEX UNIT NO. 3, FILED IN THE OFFICE OF COUNTY RECORDER OF SAN DIEGO COUNTY.

THOSE PORTIONS OF LOTS 1 TO 7 INCLUSIVE OF BLOCK 9 OF LARCHMONT, IN THE CITY OF SAN DIEGO, COUNTY OF SAN DIEGO, STATE OF CALIFORNIA, ACCORDING TO MAP THEREOF NO. 1319 FILED IN THE OFFICE OF COUNTY RECORDER OF SAN DIEGO COUNTY, MARCH 7, 1911, LYING NORTHWESTERLY AND WESTERLY OF A BROKEN LINE THAT BEGINS AT THE MID-POINT ON THE NORTH LINE OF SAID LOT 1 AND RUNS SOUTHWESTERLY IN A STRAIGHT LINE TO THE MID-POINT OF THE LINE BETWEEN LOTS 1 AND 2; THENCE SOUTHWESTERLY IN A STRAIGHT LINE TO THE MID-POINT OF THE LINE BETWEEN LOTS 2 AND 3; THENCE SOUTHWESTERLY IN A STRAIGHT LINE TO THE MID-POINT OF THE LINE BETWEEN LOTS 3 AND 4; THENCE SOUTHWESTERLY IN A STRAIGHT LINE TO THE MID-POINT OF THE LINE BETWEEN LOTS 4 AND 5; THENCE SOUTHWESTERLY IN A STRAIGHT LINE TO THE MID-POINT OF THE LINE BETWEEN LOTS 5 AND 6; THENCE SOUTHWESTERLY IN A STRAIGHT LINE TO THE MID-POINT OF THE LINE BETWEEN LOTS 6 AND 7; THENCE SOUTHWESTERLY IN A STRAIGHT LINE TO THE MID-POINT OF THE SOUTH LINE OF SAID LOT 7.

Section 5. That the taking and acquiring by said City of the real property hereinabove described is deemed necessary for the development of the Radio Canyon - Chollas Open Space Program by The City of San Diego and the inhabitants thereof, for municipal purposes; that such use is a public use authorized by law (Section 220, Charter of The City of San Diego; Sections 1240.010, 1240.110 and 1240.120, Code of Civil Procedure; Parks and Playground Act of 1909; Sections 6950-6954, 37350.5 and 51063, Government Code; and Section 61.0603 et seq., San Diego Municipal Code); that for such public use it is necessary that The City of San Diego condemn and acquire said real property; that said real property is to be used for the development of the Radio Canyon - Chollas Open Space Program which is planned and located in a manner most compatible with the greatest public good and the least private injury.

Section 6. That the City Attorney of The City of San Diego be, and he is hereby authorized and directed to commence an action in the Superior Court of the State of California, in and for the County of San Diego, in the name and on behalf of The City of San Diego, against all owners and claimants to an interest in the above-described real property, for the purpose of condemning and acquiring the fee interests as above-described, for the use of said City.
