AND ACKNOWLEDGING RECEIPT OF SUBDIVIDER'S ASSURANCE

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by WILLIAM GREGORY CLARKE, a Licensed Surveyor, entitled
"ELDORADO HILLS UNIT NO. 12 Being a subdivision of a portion
of Lot "D," Referee's Partition Map of a portion of Lot 70,
Rancho Mission of San Diego, filed in Superior Court Case
No. 15191, in the City of San Diego, County of San Diego, State
of California, together with a portion of Calle De Vida as
dedicated to public use.," is made in the manner and form
prescribed by law and conforms to the surrounding surveys; that
said map and the subdivision of land shown thereon is hereby
approved and accepted

BE IT FURTHER RESOLVED, that said Council hereby accepts
on behalf of The City of San Diego, a municipal corporation,
the easement with the right of ingress and egress for the
construction and maintenance of drainage facilities, as granted
and shown on said map and subject to the conditions set forth
thereon.

The Clerk of said City is hereby authorized and directed
to endorse upon said map, as and for the act of the Council,
that said Council has approved said subdivision map and that
the easement with the right of ingress and egress for the
construction and maintenance of drainage facilities, as

granted and shown on this map within this subdivision is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider, SHAPELL-LOMASANTAS PARTNERSHIP, that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 757438, on file in the office of the City Clerk, and in reliance on said assurance does hereby accept the final map of ELDORADO HILLS UNIT NO. 12.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
