BE IT RESOLVED, by the Council of The City of San Diego,
as follows:


Said Council hereby finds that that certain map surveyed by THOMAS H. SHUTTLEWORTH, a Licensed Land Surveyor, entitled "MADRONE VISTA Being a subdivision of a portion of Lot 6 of Encanto in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 749, filed in the office of the Recorder of said San Diego County, May 6, 1893.," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Madrone Avenue, adjacent and contiguous to Lots 1, 2, 3, 4 & 5; and in and to 65th Street, adjacent and contiguous to Lot 1, excepting therefrom the southerly 120 feet; all as shown on this map within this subdivision.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that those certain abutters' rights of access, as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map
to the Clerk of the Board of Supervisors of the County of
San Diego, California.
