

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that Street Easement Deed of WELLS FARGO BANK, N.A., as Trustee under Trust No. 306-086294, as to Parcel 1; and WELLS FARGO BANK, N.A., under Trust No. 306-086294 as ancillary Trustee for WACHOVIA BANK AND TRUST COMPANY, N.A., Trustee as to Parcel 2, executed in favor of The City of San Diego, bearing date of September 11, 1979, conveying to said City the permanent easement and right-of-way for a public street and incidents thereto, over, under, upon, and across those portions of Parcels 1 & 2, in City of San Diego, State of California, as shown at Page 2088 of Parcel Maps, filed in the Office of the County Recorder of said County, November 20, 1973, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named WARE COURT.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to cause said deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
