


RESOLUTION No. R- 250631 (R- 80- 779)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$16,856.00 by LEKAUNAS ELECTRIC, INC., a corporation, for CONSTRUCTION OF MORLEY FIELD VELODROME LIGHTING, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the Office of the City Clerk as Document No. 767083.
2. That the contribution of a \$1,250.00 check from the SAN DIEGO VELODROME COMMITTEE to be used for the above purpose is hereby accepted.
3. That the expenditure of \$1,250.00 from Capital Outlay Reserve Fund 90-245 and \$1,250.00 from Velodrome Committee Donation Trust Fund 63021, of the City of San Diego are hereby authorized solely and exclusively to supplement Council Resolution 250063 for providing funds for said project and related costs.
