BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by CHARLES W. CHRISTENSEN, a Registered Civil Engineer, entitled "SUMMER HILL Being a subdivision of Lot 1 of Mission Village Unit No. 23, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 7234, filed in the office of County Recorder of San Diego County on March 16, 1972, except therefrom all oil, gas, mineral and hydrocarbon rights and substances in and under the land, but beneath a plane 500 feet below the surface of the land but without any right of surface entry as set forth in instruments recorded June 12, 1960 as Recorder's File No. 120782, June 14, 1960 Recorder's File No. 121896 and June 14, 1960 Recorder's File No. 121897, all of Official Records and Lot 1889 of Mission Village Unit No. 21 in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 5238, filed in the office of County Recorder of San Diego County, August 14, 1963, except therefrom all oil, gas, mineral and hydrocarbon rights and substances in and under the land, but beneath a plane 500 feet below the surface of the land but without any right of surface entry, together with portions of the unnamed alley as dedicated to public use on said Map 7234 and 5238., " is hereby approved and accepted.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
