


RESOLUTION No. R-250643 (R-80-835)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the offer of HOFFMAN AIR & FILTRATION SYSTEMS, C/O KLEIN-TIEMAN ASSOCIATES is hereby accepted; and the City Manager is hereby authorized to execute a contract for the purchase of THREE (3) EACH HOFFMAN BLOWER ASSEMBLIES at a cost of \$10,121.00 each, for a total cost of \$30,363.00; terms net 30 days plus sales tax, plus an estimated freight charge of \$1,500.00.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$33,684.78 within Sewer Revenue Fund (41506) from Unallocated Reserve to Point Loma Treatment Plant Maintenance (70235).
