

RESOLUTION NO. R-250652APPROVING MAP OF MEYER INVESTMENT PROPERTIES,
INC. SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:


Said Council hereby finds that that certain map surveyed by MICHAEL J. ANDERSON, a Registered Civil Engineer, entitled "MEYER INVESTMENT PROPERTIES, INC. SUBDIVISION Being a subdivision of a portion of Lot 1 and all of Lots 2, 3 and 4 of the Manuel G. Rosa Subdivision, in the City of San Diego, County of San Diego, State of California, according to Map thereof, Map No. 3857, filed in the office of the County Recorder of San Diego County, April 7, 1958, together with all of Monel Avenue, lying southerly of Kearny Villa Road and southerly 9.00 ft. wide portion of Kearny Villa Road adjacent to said Lots 1 and 4, all as vacated and closed to public use.," is made in the manner and form approved by law and conforms to the surrounding survey; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public Sandwood Street and a portion of Kearny Villa Road for public purposes; and said street and portion of a street are hereby declared to be a public street and portion of a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements for general utility purposes over, under, upon and across Lots 1, 2 and 3, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public street and portion of a public street are accepted on behalf of the public as heretofore stated; and that the easement for general utility purposes, as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
