WHEREAS, those properties adjoining the street to be vacated will continue to have access or will be accessible because of the nature of the lots created with the approval on this date of the subdivision known as Meyer Investment Properties, Inc.; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

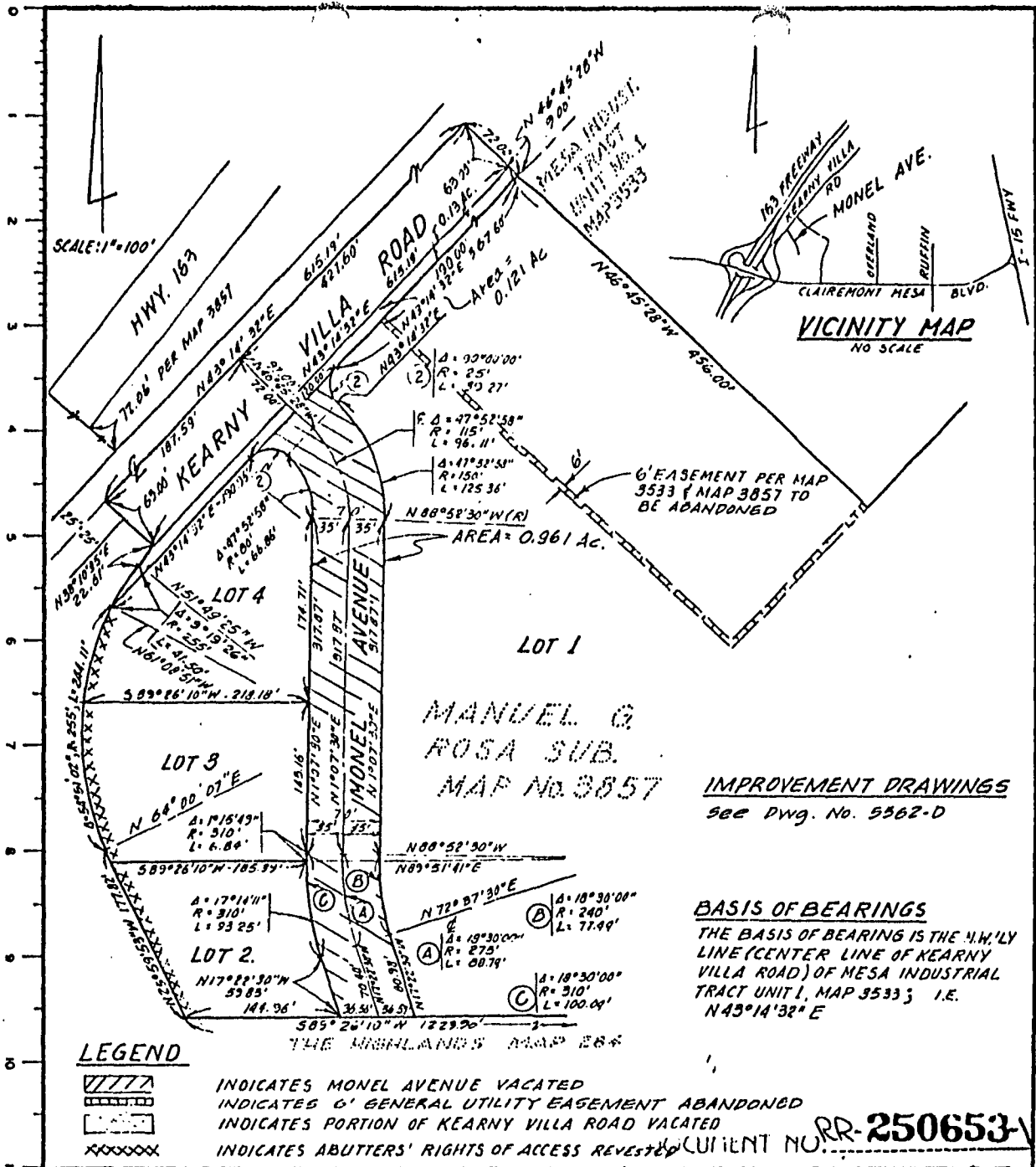
2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.
