WHEREAS, a certain general utility easement was acquired for earlier development in the area known as Meyer Investment Properties, Inc. Subdivision; and

WHEREAS, the present development of the property requires relocation of the existing general utility easement; and

WHEREAS, this aforementioned general utility easement no longer serves the purpose for which it was originally acquired; and

WHEREAS, the City will receive substitute easements where required as granted on the map of the subdivision known as Meyer Investment Properties, Inc. Subdivision; and


WHEREAS, the City has no present or prospective use for said easement and the City Manager has recommended that the City abandon its interests therein; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City of San Diego by this resolution does hereby abandon whatever right, title or interest it may have in the general utility easement, as more particularly shown on Drawing No. 14695-B on file in the office of the City Clerk as Document No. RR-250653 -1, which is by this reference incorporated herein and made a part hereof.

2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.
