EXHIBIT "A"
LEGAL DESCRIPTION

DRAINAGE EASEMENT IN P.L. 1304

Being a strip of land 15 feet wide, lying 7.50 feet on each side of the following described centerline:

Commencing at the Southwesterly corner of Pueblo Lot 1304 of the Pueblo Lands, in the City of San Diego, County of San Diego, State of California; thence proceeding Northerly along the common line between Pueblo Lot 1303 and Pueblo Lot 1304 $N00^{\circ}51'51''E$, 519.12 feet to the TRUE POINT OF BEGINNING; thence leaving said line and proceeding Easterly into Pueblo Lot 1304 $N44^{\circ}30'22''E$, 150.00 feet.

The side lines of said strip of land to be lengthened or shortened so as to terminate in the Westerly line of Pueblo Lot 1304.
