BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the UNITED STATES DEPARTMENT OF GENERAL SERVICES wherein The City of San Diego will continue to be a participant of the Government Information Center on the condition that The City of San Diego will supply the printing of a directory for said Government Information Center, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-250681.

BE IT FURTHER RESOLVED, that the expenditure of \$1,400 from the Nondepartmental Expenditures Fund is hereby authorized, solely and exclusively for the above purpose.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to execute, for and on behalf of said City, at the option of the City Manager, an extension of the one-year term for two (2) additional periods of one (1) year each, if funds necessary for the continuation of the agreement have been made available by the City Council.


