
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the Metropolitan Transit Development Board for water and sewer main relocations for the Light Rail Transit System, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-250686.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$225,900 is hereby authorized from Sewer Revenue Fund 41506 and \$412,688 from Water Revenue Fund 41502, for the sole and exclusive purpose of providing funds for the above project.
